ACTIVITIES ALSO FEATURE MENTAL HEALTH AND PSYCHO-SOCIAL SUPPORT AS WELL AS PROGRAMS TO INCREASE THIS POPULATION'S ACCESS TO ECONOMIC OPPORTUNITIES.

3. FOOD SECURITY AND ECONOMIC EMPOWERMENT: \$1.1MN PER YEAR, FUNDED BY USAID/BHA; REACHING 5,860 BENEFICIARIES. PROVIDED TECHNICAL ASSISTANCE IN BEST AGRICULTURAL AND SMALL-SCALE SUPPLY CHAIN PRACTICES TO FARMERS AND THEIR FAMILIES IN THE RURAL AREAS OF LAGUAJIRA, WITH SPECIAL ATTENTION TO THE EMPOWERMENT OF WOMEN AND YOUTH.
